Guidelines for Submission

- Submissions should be divided into two parts: Moot Problem and Applied Law. In Moot Problem, the authors will write a problem and in Applied Law, the authors will write the law applicable to the moot problem, i.e. legal provisions applicable along with the name of the state to which such provisions apply, Act/Convention etc.
- All entries must be typewritten.
- Submission must be made only in .doc format.
- Submission must follow the following rules:
 - Font – Times New Roman
 - Font size - 12
 - Line spacing – 1.5
 - Alignment - justified
 - Content must be the original work of the author and should not have been given to any other competition.
- Submission must be made on or before November 11, 2019 through e-mail with subject "1st VIPS Call for Moot Problem" at vipsmootproblem@gmail.com along with the scanned copy of Demand Draft.
