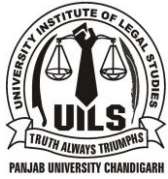
Following events will be a part of the Law Fest:

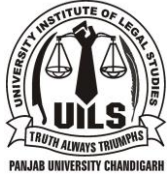

The registration fee for each event is as under:

- 3<sup>rd</sup> All India Gurcharan Singh Tulsi Criminal Law Annual Moot Court Competition, 2017 ( National Trial Advocacy Competition) Rs. 5000 /- per team (each team will consist a maximum of four members)
- 6<sup>th</sup> Dr. Gurdial Singh Dhillon UILS National Client Counseling Competition, 2017.- Rs. 3000 /- per team (each team will consist a maximum of two members)

UILS will provide boarding and lodging to the participating teams for the duration of the Competition (*i.e. from the morning of 1<sup>st</sup> February till the morning of 5<sup>th</sup> February,, 2017*) in the University campus on a sharing basis. The participants will be expected to adhere to the Rules of the Hostels and maintain high standards of discipline throughout their stay. Misbehavior of any sort by the participants will be dealt with very seriously and will lead to disqualification of the team. **Please note that separate accommodation will be arranged for boys and girls.** A pick-up and drop-off facility for the Competition and thereafter transportation only within the campus will be provided by the organizers.

The problem for the National Trial Advocacy Moot Court Competition, 2017 will be sent shortly. The problem for the National Client Competition, 2017 will be based on issues on Family Matters, Business law, Criminal Laws and other allied subjects. The detailed rules for the individual events along with the Registration Form and Travel Form will follow in the next communication.
