Rules and Regulations

The Competition shall be conducted strictly in accordance with the following rules:

- Date** : Saturday, 19th January 2019
- Venue** : Dnyaneshwar Hall, Marathwada Mitra Mandal's Shankarrao Chavan Law College, Pune.
- Timings** : All the participants are requested to report at 8.00 am.
Registration : 8.30 am., **Inauguration** : 9.30 am.

4. Eligibility :

- The Competition is open to all under graduate students from Law colleges in the State of Maharashtra & Goa.
- Every College shall depute two participants representing their College giving the details as prescribed in the Entry /Registration Form.
- Students shall carry their College Identity Cards and produce the same during the drawing of Lots at 8.30 am., failing which they shall not be eligible.
- Participants shall be in formal attire.
- The last date for Registration is 14th January, 2019 (Monday). Entries and Registration Form can be sent by post on College address or by email (mmscl@gmail.com) or in person.

- A certificate of participation shall also be given to all the participants.

7. Evaluation :

The participants shall be evaluated on the basis of following criteria:

- Coverage of the subject
- Presentation of the subject
- Eloquence
- Conclusion and Summarisation of the subject.

8. Other Conditions :

- Accommodation facilities for the participants outside Pune shall be provided by the host College on 18/01/2019.
- No Traveling or Dearness allowance shall be provided by the host College.
- Lunch and refreshment will be provided by the host College.
- A panel of Judges shall evaluate the competition and their decision shall be final and binding.
- The Result shall be declared on the same day followed by Valedictory session.
- Participants are expected to attend all the sessions of Elocution Competition.
- Organizing Committee reserves the authority to change the rules of Elocution Competition.
