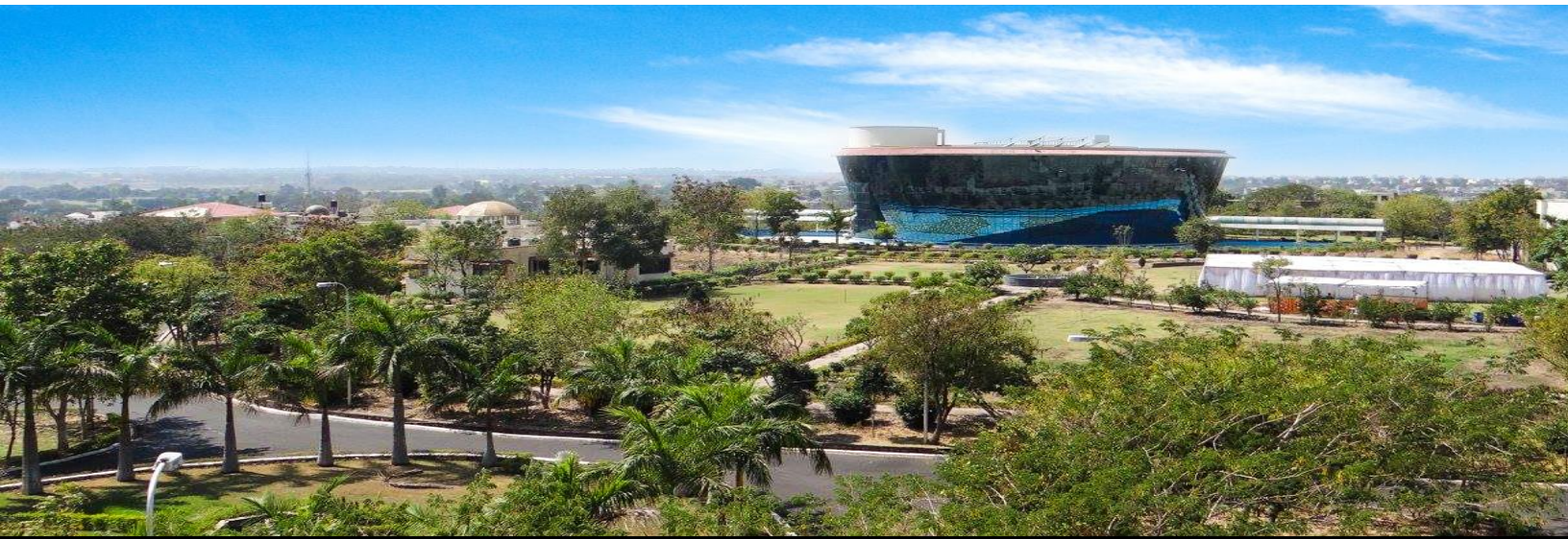

- Joint authorship is permitted to a maximum of two authors. However, both authors need to register separately. At least one author must attend the conference to present the paper.
- Submissions are to be made in electronic format only and are to be sent to mclisconference@nliu.ac.in.
- A cover letter mentioning the Name of the Author(s), Professional Position/Course/ Year of Study (as applicable), Name of the Institution/ College/University, Postal Address, Email Address and Contact Number must be submitted with the paper as well.
- The word limit for the abstract is 250-300 words.
- The full paper must be of 3000-5000 words (excluding footnotes/endnotes/annexure reports etc.). The main text should be in Times New Roman with font size 12 and line spacing of 1.5.
- The footnotes should be in Times New Roman, font size 10 with spacing of 1.0.
- One inch margins should be maintained on all four sides.
- Citation Style: Bluebook, 20th Edition
- Full paper has to be submitted in soft copy in MS Word.
