RULES & REGULATIONS
(For Synopsis)

1. Only for students pursuing **Undergraduate LAW** courses from any Central University, State University and colleges affiliated to them, NLUs and private law colleges.
2. A participant has to present a **SOFT COPY** of **ONE THOUSAND FIVE HUNDRED WORDS** (1500) in English on the topic of debate. The written submission shall include arguments both for the motion and against the motion. The topic of the written submission is **“LEGALISATION OF ADULTERY – A BOON OR BANE”** by **27 September 2019** at **voxjurist.debate@Gmail.Com**.
3. The candidates will be shortlisted based upon the written submissions made by them on the above topic.
4. Font permitted is **TIMES NEW ROMAN**, Font Size 12 for main text and footnotes should be 10, line spacing should be 1.5 for main text and footnotes shall be 1.0. The soft copy shall be send to **voxjurist.debate@gmail.com** in **.pdf** format.
5. Eight (8) best entries will be selected by a panel of judges the participants will be required to present and defend their topic of debate on the **19th October 2019 (if selected)** in the premises of SHAMBHUNATH INSTITUTE OF LAW.

NOTE: DECISIONS OF THE JUDGES AT THE COMPETITION SHALL BE FINAL AND BINDING ON ALL THE PARTICIPANTS.

IMPORTANT

1. The registration fee shall be rupees **TWELVE HUNDRED** (1200) for the said event.
2. The said amount must be transferred to the given bank account and a copy of the receipt should be attached and should be sent (**SOFT COPY**) with the registration form at **voxjurist.debate@gmail.com**.
3. The students need not write his/her name, institutional affiliation, address or any other personal information anywhere in the written submission.
4. The above and other identifying information should be provided in the prescribed Performa which should accompany the written submission.
5. The matter downloaded or copied from the internet or other sources should be specifically indicated in the written submissions at the appropriate place. Failure to do so may result in disqualification. Reproduction of the matter from the internet or other sources should not exceed **10% of the content**.
6. Preference would be given to submissions which reflect original thinking.
7. Registration of **FIRST TWENTY FIVE TEAMS (25)** shall be valid and the registration link shall be closed thereafter.
