Format of Submission

- Format of file shall be Microsoft Office Word Document in compatible mode (.doc)
- All submissions must be accompanied with a cover letter stating -
 - a) Name of the author(s)
 - b) Designation
 - c) Institutional affiliation
 - d) Contact number
 - e) E-mail id
 - f) Title of the paper
- The cover letter should state that the article is original and has never appeared in any other publication.
- It shall be followed by the abstract. The second page should commence with the main body of the manuscript.
- In accordance with the double-blind process of review, the name of the authors and their institutional affiliation must not be mentioned or indicated anywhere in main body of the manuscript.
